



## 2010 North Carolina Child Passenger Safety Conference Awards Nomination March 11-12, 2010 Atlantic Beach Sheraton

The North Carolina Child Passenger Safety Training Committee is accepting nominations in recognition of outstanding CPS contributions by NC Technicians, Instructors, programs, and advocates. Individuals can be nominated in more than one area, however they must meet the criteria given for said recognition. **NOMINATIONS ARE NOT VALID UNLESS SUBMITTED BY THIS FORM.**

Nominations must be received by the committee by **5:00pm, Wednesday January 13, 2010** in order to be considered for recognition. **Late nominations will NOT be accepted and considered.** Nominations will be accepted in the following categories:

### **Child Passenger Safety Technician of the Year:**

This individual must be a currently certified CPS Technician. The individual must show extraordinary dedication to, and support of Child Passenger Safety programs and activities. Individual should have made contributions to their local and/or state level CPS program(s), by means of participation in and/or coordination of CPS events in NC. Individual should exemplify the focus and mission of CPS programs in the state.

### **Child Passenger Safety Technician Instructor of the Year:**

This individual must be a currently certified CPS Technician Instructor. The individual must have shown extraordinary dedication to Child Passenger Safety programs in the state. The ideal nominee will have remained current on changing technologies and information. He/She should have contributed to and shown dedication to the continuation and/survival of Child Passenger Safety programs by means of community involvement and/or participation in state CPS activities. The individual should have exemplary teaching skills and be aware of the needs of their students.

### **Child Passenger Safety Program of the Year:**

The program must be current in all areas of CPS documentation and activities. The ideal nominee for CPS Program of the Year would be a program that shows dedication to the continuation of CPS programs both local and state. The program should have developed activities that promote self-standing CPS programs and activities. The ideal program has been able to show data that supports a reduction in motor vehicle related injuries and/or deaths in its program area. The ideal program should also have been able to maintain participation of members and by their activities possibly shown an increase in active recruitment of certified CPS technicians.

### **Child Passenger Safety Advocate of the Year:**

This nominee should not be a currently certified CPS technician. The ideal nominee for CPS Advocate of the Year would be an individual who has shown support for and dedication to the continuation of CPS activities at the local and/or state level. Participation in or help in coordination of CPS activities is very important. The nominee should have shown dedication to bridging the gap between the public and the CPS community.

### **Known CPS Saves:**

This nomination is to recognize known/documented CPS saves.

This information will be used to highlight and recognize any known life saved by the actions related to CPS programs and/or events. Documentation can include data from program related materials, letters and/or statements from individuals who were involved in the collision and/or save.
